GATE KIOSK AT SUNFLOWER

FROM ELWCA PROPERTY MANAGER

Dear Board of Directors, I am writing to inform you that the ELWCA Board of Directors has voted to activate the Sunflower gate kiosk. While this gate will continue to be designated as residents-only, it is important to note that if a vehicle without proper credentials becomes trapped, the driver will have the option to press the green button for access. New signage will be implemented to discourage commercial vehicles from entering at the Sunflower gate. The kiosk will function similarly to our other kiosks, capturing the driver's face and vehicle information for our records and, if necessary, for law enforcement. This enhancement aims to reduce delays caused by non-resident vehicles, allowing for smoother access for our residents and minimizing wait times on Tampa Rd. The Board understands that change can be challenging and that not everyone may agree with the implementation of the kiosk, but we encourage the communities and its residents to give it a chance. Your understanding and support are crucial as we work together to improve our shared experience.
